

“Win a pair of flights to Malaysia courtesy of Malaysia Airlines” PRIZE DRAW TERMS AND CONDITIONS

By participating in the **Win a pair of flights to Malaysia courtesy of Malaysia Airlines** Prize Draw (the “**Prize Draw**”), you fully agree and accept these Prize Draw Terms and Conditions (“**Prize Draw T&Cs**”) together with any specific instructions and terms for such Prize Draw which may be mentioned on the relevant section of the website (the “**Prize Draw information**”).

1. Eligibility

- a) The Prize Draw is open to entrants in UK only.
- b) You must be aged 18 or over to participate. Proof of identity may be required.
- c) Employees of the Club or their family members or anyone else connected in any way with the Prize Draw or helping to set up the Prize Draw shall not be permitted to enter the Prize Draw.
- d) To enter the Prize Draw, entrants must have access the internet and be registered with a Club account. All entries must be made directly by the person entering the Prize Draw.
- e) By entering the Prize Draw you confirm that all information submitted by you is true, current, and complete.

2. Prize Draw Information and How to Enter and Selection Process

winner cannot be contacted within three days of the closing date or if the winner fails to communicate their acceptance of the prize to the Club within 48 hours of being contacted by the Club, or is unable to comply with these Prize Draw T&Cs, the Club reserves the right to offer the prize to the next eligible entrant drawn at random.

3. Prize

- a) This prize is: One (1) winner will receive two (2) Economy Class return tickets on the routing London – Malaysia – London

The validity of this ticket is from 15 May 2019 until 15 May 2020, with the exception of blackout dates, 07July19-14August19 // 12December19-15January20 // 03April20-14April20 (travel permitted Mon/Tue/Wed/Thu only vice versa). **Booking must be made no later than 15 June 2019. Seats are subject to availability at the time of booking.**

- b) The prize is subject to these Prize Draw T&Cs, and any further regulations relating to the use of the prize, which may include ticket terms and conditions of issue and applicable venue regulations. By accepting the prize, the winner agrees to comply with any and all applicable terms and conditions and regulations.
- c) No cash alternative to the prize will be offered. The prize is non-refundable and non-transferable. Prizes are subject to availability and we reserve the right to substitute any prize with another of equivalent value without giving notice.

for strike, lock-out, labour dispute, illness, act of God, natural disaster, adverse weather conditions, war, riot, civil commotion, accident, epidemic or pandemic, malicious damage, fire, flood and/or storm, compliance with law or governmental order, rule, regulation or direction, breakdown of plant, machinery or transportation. The Club is not responsible for any loss or damage caused to you as a result of any of these occurrences.
