

“Win two tickets to LFC v West Ham at Anfield & 4 Falken Tyres” PRIZE DRAW TERMS AND CONDITIONS

By participating in the **Win two tickets to LFC v West Ham at Anfield & 4 Falken Tyres** Prize Draw (the **“Prize Draw”**), you fully agree and accept these Prize Draw Terms and Conditions (**“Prize Draw T&Cs”**) together with any specific instructions and terms for such Prize Draw which may be mentioned on the relevant section of the website (the **“Prize Draw information”**).

1. Eligibility

- a) The Prize Draw is open to entrants in the UK only.
- b) You must be aged 18 or over to participate. Proof of identity may be required.
- c) Employees of the Club, the Promoter or their family members or anyone else connected in any way with the Prize Draw or helping to set up the Prize Draw shall not be permitted to enter the Prize Draw.
- d) To enter the Prize Draw, entrants must have access the internet and be registered with a Club account. All entries must be made directly by the person entering the Prize Draw.

 - Only tyre models and sizes from Falken's existing Car/SUV/4x4 ranges are available. No alternatives will be provided.
